International Communications Association 2022 (Forthcoming) "Stitched Wounds and Virtual Prayers: Collective Sentiment, Affective Sharing, and Facebook-Based Community Building in Public Health Spaces During the COVID-19 Pandemic."

This co-authored paper examined Facebook comments on rural and small-urban public health department pages in the state of Illinois during the first 16 months of the COVID-19 pandemic. It used semantic and textual analysis to identify and contextualize expressions of religiosity and support as they related to the bridging and bonding elements of community formation. This was performed in order to understand how local public spheres emerge from the geographically-rooted digital interactions of local actors in community-specific contexts.

"Sun Signs Don't Matter (But Geminis Are The Worst): The Construction of Astrologically-Based In-and Out-group Identities in Virtual Spaces."

This paper utilized an examination of the ways in which social media users define themselves and others within the immutable and, in some respects, arbitrary categories contained within astrology is a useful window into the formation of virtual identities. To this end, it identified, discussed, and examined ways in which users of the subreddit /r/Astrology simultaneously build and deconstruct sun sign-based identities using the affordances available to them within the Reddit's technologically-mediated and the subreddit's human-moderated environment(s).

MidweSTS 2017

"Constructing Consent Online: F(etish)-List as a Community of Practice."

This presentation proposed a potential framework for the examination of fraught negotiations on F-List, a website and online community dedicated to the facilitation of fetish-based erotic roleplay, with the goal of better understanding how tacit knowledges intersect with the use of language and interfaces in order to enable the production of safety and consent in online interactions, as well as of furthering exploration of the ways in which delicate and fraught negotiations inflect upon the shared culture and practice of online communities. My analysis was based not only upon utilizing critical, feminist, and queer theories of space in order to examine the power of the interface, but also upon considering the users of F-List as a community of practice. Borrowing this particular window from organizational studies allowed for the incorporation of theories of socialization theory alongside critical queer and feminist theories of science and technology studies in order to understand not only the way in which the users of F-List craft and control their erotic interactions, but also to more broadly examine how implicit consent is reached in high-stakes negotiation online.

MidweSTS 2016

"Performing Dissent: Virtual Bodies, Trolling, and the Ethics of Disruption."

I discussed trolling behavior based upon an examination of the virtual world as a constructed social space where virtually constructed bodies can convene and interact. This was conducted in order to understand the methods and ethics of trolling as a discursive practice in an effort to successfully situate their brazen and controversial methods within the evolving context of cultural and political discourse. This led to a discussion of the ways in which the methods of discourse employed by trolls has been used in ways that subvert, rather than support, reactionary agendas and that promote inclusiveness within virtual spaces, while encouraging the audience to consider the conversations that trolling begins as a valid site for research into virtual spaces.

Gender, Work, and Organization 2016 9th Biennial Conference "Reddit and the Normative Nerd: Interfaces, Discourse and Power in Casual Epistemic Communities."

Examined Reddit's construction as a social space and how power is allocated and codified within casual techno-scientific discourse. Explored ways in which this allocation of power can be modified, coopted, and challenged from within the system's infrastructure, drawing upon the experience of creating a subreddit dedicated to discourse around the interplay of feminism and technology

As part of a group presentation, I spoke about my paper, "Encountering the Unexpected Other: On Building an Intellectual Commons." This paper recounts my problematic experience in creating a co-collaborative syllabus about hacker culture with a tech journalist. Though our goals in addressing the misconceptions about hacker culture differed, we utilized principles exemplified in new technological methods of collaboration in order to find a mutually workable method of instruction.
